AND WHEREAS, Furthermore, vide Notification No. 01 of 2024 dated 01.07.2024, following posts were also advertised under SO 364 of 2020 dated 27.11.2020, for engagement: -

AND WHEREAS, in order to determine the eligibility of the candidates for entering into written test (vide Office Order No. 43-GUMC of 2025 dated 05.03.2025) designated committees, were constituted to scrutinize the application forms of the candidates in consonance with the prescribed notified qualifications and method of recruitment of the above referred posts, as envisaged in Government Order No. 886-JK(HME) of 2020 dated 27.11.2020;

AND WHEREAS, the committees, submitted the checklist of the applicant candidates wherein some of the candidates had been found, having deficient documents, as required, for their eligibility, while as some candidates have been found not fulfilling the requirement of eligibility parameters for the posts, against which they have applied;

AND WHEREAS, the rejections and the deficiencies were notified vide Notification dated 04.06.2025. This was followed by another notice dated 09.07.2025. Further left out candidates were telephonically informed about their deficient documents, so as to give them wide opportunity to be part of selection process;

AND WHEREAS, out of total 401 deficient candidates only, 287 candidates furnished their documents to this office and rest 114 candidates totally failed to submit the same;

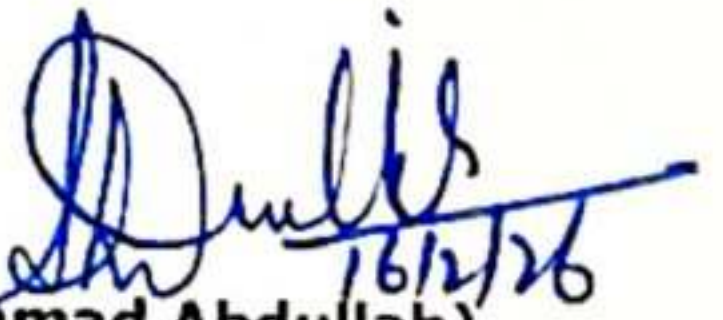
AND WHEREAS, the matter was placed before the designated Selection Committee constituted in terms of rule 06 of SO 364 of 2020 dated, 27.11.2020, twice. The quorum of the Committee examined every pros and cons of the cases and decided to have the candidature of candidates been rejected forthwith as they failed to submit their deficient documents despite of ample opportunities. The Committee further took a decision to have the Selection Process in respect of post of Dresser, one each for Associated Hospital and Operation Theater, been placed at halt, till clarifications with regard to prescribed qualifications is received from the Health and Medical Education Department.

Now, therefore in view of above, the candidature of candidates, forming annexure to this notification, who applied for various categories of posts in GUMC Ganderbal under SO 364 of 2020 dated 27.11.2020, and failed to submit their deficient documents, is hereby rejected forthwith, however this does not include the rejection of candidature in respect of the post of Dresser, Associated Hospital, and Operation Theater, which shall be notified separately.

This is however with the right that if any of the candidate, having any genuine request or grievance, may approach to the Officers of the Govt. Unani Medical College cum Hospital, Nawabagh, Ganderbal, Kashmir, during any working day within the period of 10 days, from the dissemination of this notice on the college website viz. www.gumck.org.in
