

As recommended by the Selection committee sanction is hereby accorded to the engagement of Mr. Umer Bashir, S/O Bashir Ahmad Mir R/o Kanir, Chadoora Budgam as lecturer Arabic in Government Unani Medical College cum Hospital Ganderbal, Kashmir on Academic arrangement basis, in terms of the Jammu & Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules 2020, notified vide SRO 364 dated 27.11.2020 for a period of one year or till the post is filled up on regular basis whichever is earlier.

The selected candidate shall report to the Principal Govt Unani Medical college Ganderbal for joining within a period of 21(twenty one) days from the issuance of the engagement order failing which his engagement shall stand cancelled ab-intio without any further notice.

The engagement shall however, be further subject to the following conditions:-

- a) The term of engagement on academic arrangement basis shall be initially for a period of one-year extendable upto maximum of six-years or till selection/promotion is made in accordance with the rules of recruitment governing the post whichever is earlier.
- b) The extension upto 03 years shall be made on year to year basis by Principal Government Unani Medical college and for engagement beyond three years, the case will be considered by the Govt. Once approved, Principal concerned shall be authorize to grant further extension for another three years.

- c) The Extension so granted under rules, shall not be beyond a period of six years under any circumstance.
- d) The engagee shall be always on academic arrangement only without any conferment of any preferential right for regular appointment against the post, which shall be made strictly in accordance with the relevant recruitment rules;
- e) The engage shall execute an agreement with the government on prescribed format.
- f) The salary of the engage shall not be drawn to him unless satisfactory repot with regard to his character and antecedents is received in his favor from CID.
- g) The other terms and conditions as envisaged in Jammu & Kashmir Medical and Dental Education( Appointment on Academic Arrangement Basis)Rules 2020, notified vide SRO 364 dated 27.11.2020 shall also apply in toto.
