Unani Medical College and Hospital, Shalteng, Srinagar-190017, Jammu & Kashmir" with 60 seats in UG (BUMS) course under section 13A of the IMCC Act, 1970 from the academic session 2020-21- Letter of Permission- reg.

Sir/Madam,

I am directed to refer to your application dated 28.05.2019 on the subject cited above, which was forwarded to the CCIM vide Ministry's letter of even no. dated 17.12.2019 for necessary action as per the provision of IMMCC Act, 1970 and relevant regulations.

- 2. In view of the Ministry's letter no. 11011/03/2011 EP (H) Part dated 01.09.2017, wherein mentioned as "the Council shall inspect college and issue Letter of Intent (LOI) at their level, if the college is found eligible. Accordingly, the CCIM had issued Letter of Intent to you vide council letter No. 11-67/2019-Unani (NP) 13A dated 19.08.2020 to establish a new Unani College in the name of Govt. Unani Medical College and Hospital, Shalteng, Srinagar-190017, Jammu & Kashmir' with 60 seats in UG (BUMS) course from the academic session 2020-21 under section 13A/13C of the IMCC Act, 1970
- 3. The CCIM had carried out an inspection of the institution on 01-02.12.2020 to assess the available facilities of teaching and practical training for conduction UG (BUMS) course and to verify the compline of shortcoming informed by the CCIM under the section 13A of IMMC Act, 1970 and forwarded its recommendation and report to the Ministry. On examining the same in terms of Regulation 3 and 10 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Unani Colleges and attached Hospitals) Regulations, 2016", provisions under the IMCC Act, 1970, relevant regulations made thereunder and as per approved Standard Operative Procedures (SOPs), it is found that the College is fulfilling notified and approved criterion for Issuing Letter of Permission for conducting UG (BUMS) course from the academic session 2020-21.

- 4. It has, therefore, been decided by the Central Government to issue Letter of Permission to the Joint Director (Planning), Health Medical Education Department, Civil Secretariat, Srinagar to start new Unani College in the name of "Govt. Unani Medical College and Hospital, Shalteng, Srinagar-190017, Kashmir J&K" with 60 seats in UG (BUMS) course for the academic session 2020-21 under section 13A of the IMCC Act, 1970 course from the academic session 2020-21.
- 5. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 60 UG seats shall be treated as all India quota. The counseling for seats under all India quotas shall be conducted by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State. If any seats are not filled up in the Central Counseling, the same shall be transferred to the said Counseling Authority to admit students as per their rules/ reservation policies/norms. The permission of the college stands withdrawn if the college fails to comply with the Central counseling for all India quota or the students admitted thereunder.
- Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under IMCC Act & Regulations made thereunder.
- Discrepancies, if any, may be immediately brought to the notice of Board of Governors, CCIM and the Central Government.
- The following requirements should be fulfilled by the college by 31<sup>st</sup> December, 2020 to get permission for the session 2021-22:
  - all the Requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Unani Colleges and attached Hospitals) Regulations, 2016;
  - (ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Unani); and
  - (iii) all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled in toto
- 9. The college administration will ensure that sufficient qualified teachers and non-teaching staff in the college and requisite staff in the hospital, as per the relevant CCIM regulations, are in position before the admission of the first batch of student in the 1<sup>st</sup> professional of BUMS course is made, under intimation to the Central Government and CCIM.
- 10 The college has develop the requisite infrastructure for the II<sup>nd</sup>, III<sup>nd</sup> and IV<sup>th</sup> professionals well in time as per the CCIM norms which will be verified and reported by the CCIM at least three months before the start of next professional and accordingly, the permission for taking admissions in subsequent academic session will be issued.
- The college administration may take up the matter for recognition of the qualification under section 12(2) of the IMCC Act, 1970 at that time when first batch of students admitted against this course appears for the first final professional examination of the said course.

- 12. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to CCIM under intimation to this Ministry. The CCIM will verify that the conditions have been fulfilled by means of an inspection and submit a report along with its assessment in this matter to the Ministry of AYUSH for considering the permission matter from the academic session 2021-22.
  - This issues with the approval of Competent Authority.
