### Age:

As per provision to rule 5 of the J&K Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020 the maximum age limit at the time of submission of application forms shall be 63 years. This is with the rider that in service officials shall not be eligible for engagement under these rules.

The appointee (s) shall also be entitled to house rent allowance as applicable to in service candidates carrying the minimum of the pre-revised scale of the post subject to fulfillment of the conditions provided under the relevant rules in this regard and appointee(s) shall not be entitled to any other monetary benefits what so ever.

# Conditions of Service:

- In the matter of discipline and conduct an appointee shall be governed by the rules, regulations and orders in vogue in the UT Civil Services on the subject;
- The appointee shall be entitled to only 15 days causal leave in a calendar year and any other kind of leave based on the proper justifications shall be at the discretion of appointing authority;
- The appointment under these rules shall not entitle the appointee to any preferential claim for regular appointment under normal process of selection/appointment;
- The period of engagement under SO 364 of 2020 shall be initially for a period of one year extendable upto maximum of 6 years on the basis of good performance, or till such time the posts are filled up under normal procedure whichever is earlier;
- The services of an appointee under these rules shall be terminable before the expiry of the tenure of appointment with one months notice from either side or on payment of one month salary in leave of the notice by the appointing authority;
- The appointee(s) under these rules shall have to execute an agreement with the Government on the prescribed form;
- In respect of the faculty posts of the GUMC Ganderbal, the engagement of the appointee shall be terminated on attainment of 65 years of age by the appointee.

# Mode of Selection;

The selection of the candidates for the faculty posts shall be made by the selection committee constituted under Sub Rule 01, of Rule 06 of SO 364 of 2020 dated 27.11.2020, in accordance with the selection criteria prescribed by Health and Medical Education Department in terms of Government Order No 554-JK (HME) of 2023, dated 11.07.2023.
