Applications on plain paper along with Bank Draft worth Rs. 500/- (Rupees five hundred), on the name of Principal, Govt. Unani Medical College Cum Hospital, Nawabagh, Ganderbal, Kashmir, are invited from the eligible candidates for engagement **of one (01) post of Pharmacognist**, under Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020, notified vide S.O 364, in the Govt. Unani Medical College cum Hospital, Ganderbal, Kashmir. The description of the post along with requisite qualification is given hereunder: -

The application forms in original with full particulars and address, including mobile numbers, should be supported with the following documents: -

- (i) Marks Certificate;
- (ii) Post Graduate Degree/Degree Certificate issued by the University concerned
- (iii) Date of birth certificate issued by the J&K, Board of School Education
- (iv) Domicile Certificate issued by the competent authority
- (v) An affidavit duly attested by the First Class Judicial/Executive Magistrate to the effect that the candidate is not in any active Government service.
- (vi) Bank draft of Rs. 500/- (Five hundred only) in favour of Principal, Govt. Unani Medical College Cum Hospital, Nawabagh, Ganderbal, Kashmir.

- (vii) Four (04) passport size photographs

Mode of selection

The selection of the candidates shall be made by the designated Selection Committee, constituted in terms of Sub Rule (2) of Rule 6 of the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020.

During scrutiny of the application forms by the designated Committee, the candidates who are found ineligible shall be formally communicated about the rejection of their candidature.

The engagement shall be for a period of one year, extendable up to a maximum of six years (one year at a time and subject to good performance and conduct) or till the selection is made in accordance with the recruitment rules, governing the respective posts, whichever is earlier. Further, the extension shall be made by the Principal concerned on year to year basis for the first three (03) years and beyond three years, the case(s) will be considered by the Government and once approved, the Principal concerned shall be the authority to grant further extensions for another three years, however no extensions shall be granted beyond the period of six (06) years under any circumstances and this shall be clearly indicated in the engagement order.

The appointee shall also be entitled to house rent allowance as applicable to in-service candidates carrying the minimum of the pre-revised scale of the post subject to the fulfilment of the conditions provided under the relevant rules in this regard. An appointee shall not be entitled to any other monetary benefits whatsoever.

Age at the time of submission of application forms

The maximum age at the time of submitting of applications forms for the above referred posts, should be 63 years, in terms of Rule 5 of the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020, notified vide SO 364 dated 27.11.2020.

Other terms and conditions

- (i) The engagement under these rules shall not entitle the appointee to any preferential claim for regular appointment under normal process of selection/appointment;
- (ii) The services of appointee under these rules shall be terminable before the expiry of the tenure of appointment with one month's notice, from either side, or on payment of one month's salary in lieu of notice by the appointing authority.
- (iii) The in-service officials shall not be eligible for engagement under these rules.
- (iv) The appointment of the appointee shall be terminable without notice by the appointing authority whenever the post is filled up under rules and the appointee shall have no claim against the Government or the appointing authority.
- (v) The appointee on academic arrangement basis shall submit himself/herself to the orders of the Government and the officers and the authorities under whom he/she may be placed from time to time by the Government.
- (vi) The appointee shall be entitled to a casual leave of 15 days for the period of one year. Any leave beyond that period, on whatever ground it may be, shall be at the discretion of the appointing authority, on justified grounds.
- (vii) The appointee shall have to execute an agreement with the Government on the prescribed form, in terms of S.O 364 of 2020 dated 27.11.2020

Conditions of Service

In the matter of discipline and conduct an appointee shall be governed by the rules, regulations and orders in vogue in the UT, Civil Service on the subject.

Last date for submission of application forms

The application forms completed in all respects should be deposited in the office of the Principal, Govt. Unani Medical College cum Hospital, Nawabagh, Ganderbal, Kashmir either **by person or through speed post by or before 20th of March, 2026** under proper receipt, during office hours. No application shall be entertained after cut of date viz 20.03.2026 in any circumstances. In case of any holiday on 20.03.2026, the cut of date shall be the next working day accordingly.


